# MINUTES THE NESKOWIN REGIONAL WATER DISTRICT BOARD OF COMMISSIONERS REGULAR MEETING August 25th, 2022

Commissioners Present: Steve Rubert, Gary Dunn, Frank DeMars, Commissioners Absent: John Metschan and Brenda Freshman

Staff Present: Troy Trute and Joy Neufeld Public Present: Guy Sievert and Paul Bender

## **CALL TO ORDER:** (00:00:16)

President Steve Rubert called the regular Board meeting to order at 1:01.08 pm; this meeting was hosted by Zoom Meetings remotely.

#### **BOARD MEMBER RESIGNING:** (00:00:33)

- 1. Steve introduced Guy Sievert and Paul Bender, visiting community members who are interested in becoming Board members.
- **2.** Troy and the Board discussed Gary Dunn's upcoming resignation from the Board. Gary would be resigning at the end of September 2022.
- **3.** The District needs an official resignation letter from Gary to send to the county. The Board needs to appoint a new Board member, and that new Board member needs to run for office in the May 2023 election.

#### **REVIEW MINUTES:** (00:06:40)

- 1. Troy asked the Board if Joy could do a less detailed minutes to save time for other work, and the Board agreed to give that a try.
- 2. The Board reviewed the draft minutes from the Regular Board Meeting on July 28th, 2022. \*\*Motion\*\*: Frank DeMars moved to accept the minutes as presented. Gary Dunn seconded the motion, which passed unanimously.

### **OPERATORS REPORT:** (00:11:26)

- 1. There were several new water service hookups.
- **2.** There were no service interruptions during the month.
- 3. A pump and motor at the Hawk Hills pump station needs replacing.
- **4.** The district is currently doing hydrant and valve maintenance.
- 5. The chlorine injection line at the water plant was replaced.
- **6.** The District should have a complete power protection plan in September.
- 7. Both Bac-T results were "absent" (non-detected).

Gary Dunn seconded the motion, which passed unanimously.

#### 3. WATERSHED LAND PURCHASE - POSSIBLE EXECUTIVE SESSION: (01:00:38)

- **3.1.** The contract for the appraisal services has been signed.
- **3.2.** Troy needs to do some definition rewrites on the grant.
- **3.3.** Frank discussed the possible liabilities to the District by purchasing the watershed land. Frank and Steve had a disagreement about this topic and Frank abruptly left the meeting saying he was resigning. Since there was no longer a quorum the Board meeting ended.
