MINUTES:

THE NESKOWIN REGIONAL WATER DISTRICT BOARD OF COMMISSIONERS REGULAR MEETING September 21, 2023

Commissioners Present: John Metschan, Guy Sievert, and Paul Bender.

Commissioners Absent: Steve Rubert and Brenda Freshman.

Staff Present: Troy Trute and Joy Neufeld.

Public Present: None.

CALL TO ORDER: (00:00:34)

John Metschan called the regular Board meeting to order at 1:00.00 p.m. This meeting was held at the District's Water Plant at 5880 S. Fairway Rd. and hosted remotely via Zoom Meetings.

REVIEW MINUTES: (00:01:05)

1. The Board reviewed the draft minutes from the August 31, 2023 Regular Board Meeting. **Motion**: Paul Bender moved to accept the August 31, 2023, Regular Board Meeting minutes as presented; John Metschan seconded the motion, which passed unanimously.

OPERATORS REPORT August 2023: (0:01:50)

1. Distribution System

1.1. Two minor water service interruptions this month were caused by a leak on a service line in the South Beach area. We have fixed the leak and notified Road and Driveway of the needed asphalt work. There was a minor incident involving a vehicle hitting a detached excavator bucket that was set off to the side of our work site during our repairs.

2. Treatment System

- **2.1.** Our bacteriological testing has had no detectable amounts of coliforms this month.
- **2.2.** Stream flows are slightly below average for this time of year but are currently adequate.
- **2.3.** The water filter is running well and is producing excellent potable water. We will need to do our major filter pinning and cleaning operations before fall and any major storms
- **2.4.** Troy said one of the pump's motors at the plant stopped working and must be replaced.
- **2.5.** John asked if anyone applied for the maintenance worker position. Troy said no.

FINANCIAL REPORT: (0:10:40)

1. Troy reviewed the financial reports for the end of August 2023.
